The State should prepare action plan for completion of all the works sanctioned under RCPLWEA including the instant bridge works by 31st March, 2023.
- As per the amended provision of Operational Manual, overall timeline from sanction of projects to commencement of works is 72 days. State should ensure to implement this provision of the guidelines in letter and spirit.
