Sir,

I am directed to refer to the State Government's letter Nos. letter no. 9319/15636/RC-10/CGRRDA/2021 dated 24.08.2021 on the subject mentioned above and to convey that the Ministry accords its approval for dropping of 1 Long Span Bridges (LSBs) sanctioned under PMGSY-III (Batch-I, 2020-21), as it fulfills the criteria for dropping.


No dropping has been done so far under this Phase.
