- The selection of applicant for empanelment will fully depend upon the decision taken by the CEO of JSRRDA and no claim shall be accepted against the decision of the CEO of JSRRDA.
- The empanelment will be for a period of one year and JSRRDA will have the right to take the decision of de-empanelment of any empanelled candidate without assigning any reason to him.
- Empanelled Engineers will be assigned work as State Quality Monitors (SQMs) as per requirement of JSRRDA. The State Quality Monitors (SQMs) are required to inspect PMGSY works allotted to them by JSRRDA within the state of Jharkhand. The inspection will be done as per PMGSY Guidelines (available on website:-www.pmgsy.nic.in) and the directions given by JSRRDA.

- Age of candidate should not be more than 69 years at the time of interview.
- SQM will be required to submit and upload their inspection reports (in pdf file) on OMMAS (PMGSY online website) in prescribed format up to 28th of the month.
- No payment will be made for inspections of sub standard or poor quality. In this regard decision of CEO of JSRRDA is final. SQM whose work is Unsatisfactory may be deempanelled without giving any reasons and the decision of CEO, JSRRDA will be final.
- SQM will be paid an honorarium @ Rs. 3500.00/- (Rs. Three thousand five hundred only) per day for the inspection of road/bridge as assigned to them by JSRRDA.

In plan scheme minimum one scheme and in maintenance scheme minimum two schemes will be inspected by SQM per day.

Similarly in plan scheme maximum two schemes and in maintenance maximum four schemes will be inspected by SQM per day.

In addition to above, for inspection period Daily Allowance @Rs. 500.00 per day, lodging charges @Rs. 2500.00 per day maximum (on production of actual receipt) and travel expenses @ Rs. 10/- Km (from Residence District Headquarter of SQM to District Headquarter of site visited) will be admissible as per actual voucher submitted.
