Subject: Inspection of PMGSY projects not inspected "EVEN ONCE" by State Quality Monitors (SQMs), to be inspected in the month of September, 2021 - regarding

Madam/ Sir,

This is regarding inspection of PMGSY and RCPLWE works by State Quality Monitors (SQMs) in the month of September, 2021.

2. It has been observed that there are substantial number of on-going and completed works in the States, which have not been inspected by the SQMs "EVEN ONCE" from the date of award. This issue has been raised in the monthly review meetings in last couple of months. However, substantial number of works are still there, which have not been inspected by the SQMs even for the first time.
3. From analysis of OMMAS data, it is observed that not all the SQMs are assigned duties every month and the number of works assigned to SQMs are also not as per the guidelines. SQMs are being assigned only one district in a month and only 5-6 works out of which they inspect less than 4 works per month. It is expected that SQMs are assigned two districts and around 8 to 10 works in each of the districts every month.
4. An statement of number of works not inspected by SQMs "EVEN ONCE" has been extracted from OMMAS on 03rd September, 2021 and is enclosed for your ready reference. You are requested to ensure that all those works which are more than three months old and are progressing well (substantial quantities of earth work completed or are at GSB or above level) are inspected in the month of September, 2021, on priority. If required, SQMs may be allowed to carry out inspection for more than 10 days in a month to achieve the inspection of all such works.
5. It is also requested that a statement of all those works, which may not be inspected even once till 30th September, 2021, be sent to the undersigned indicating reason against each work, for not getting it inspected by SQM.
