Subject: Release of Financial Incentive under Pradhan Mantri Gram Sadak Yojana (PMGSY) to the State of Rajasthan for the year 2019-20-reg.

Sir,

1.1 I am directed to convey the sanction of the President of India to the payment of Grants-in-aid amounting to **Rs. 184,74,00,000/- (Rupees One Hundred Eighty Four Crore and Seventy Four Lakh Only)** to the State of Rajasthan for "**Financial Incentive**" as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the **Financial Year 2019-20**.

1.2 **These funds are exclusively meant for periodic maintenance of roads already constructed under Pradhan Mantri Gram Sadak Yojana.**

1.3. The State Government must transfer these funds to Rajasthan Rural Road Development Agency (RRRDA) within 3 working days positively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The State Government is required to endorse a copy of the release order to the Government of India at the following address:

1.4 Rajasthan Rural Road Development Agency (RRRDA) has nominated Shri Sanjeev Mathur, Chief Engineer & CEO (PMGSY), Rajasthan Rural Road Development Agency (PWD), Government of Rajasthan as the Empowered Officer.

1.5. The funds released by the State Government shall be kept in a separate Savings **Bank Account No.61000371210 (IFSC Branch Code No.SBIN0031820), State Bank of India, PWD, complex, Jacob Road, Civil Line, Hasanpura, Jaipur-302006**. It shall be ensured by the Rajasthan Rural Road Development Agency (RRRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of Rajasthan Rural Road Development Agency (RRRDA) to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

1.6. The State Governments are requested to credit matching State Share against the funds released vide this letter in respective SRRDA's accounts as per PMGSY guidelines and update the status on OMMAS.

1.7. The Empowered officer shall issue standing instructions to the Bank regarding the names of Authorised Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payment as per the agreed work programme for the respective package.

1.8. No Utilization Certificate is pending from the agencies Rajasthan Rural Road Development Agency (RRRDA).

1.9. The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the Principal Accounts Office of the Ministry in terms of Rule 211 (1) of the General Financial Rules (GFR).




