### **Overview of the Project**

**Introduction of Work:-** This Road is located in Pirtand block, District-Giridih (Jharkhand). It starts from Chirki Bazar and connect village like Chirki Bazar, Chirkidih, Chalkari mission, Hatyatand. This road is a key Component of Rural Development by promoting access in economic and social services and thereby generating increased agricultural incomes and productive employment opportunities. It is also a key ingredients in ensuring Poverty reduction . These villages have 80% schedule Tribe/ SC Population, who are below poverty line and they have not connected with pucca road.

**Need for Work:-** Up gradation of this rural kutcha road is necessary for upliftment of rural people and for the growth of the rural market centers and rural hubs connecting to growth centers. Rural hubs will certainly boost the strategy of facilitating poverty alleviation through creation of rural Infrastructure.

### **Implantation Process**

**How the work was implemented:-** This work was implemented by Rural Development Special Division Giridih. PIU, JSRRDA through Procurement tender by competent authority. This work was checked by State Quality Monitor(SQM) and will be checked by National Quality Monitor(NQM). contractor has established a laboratory for testing of material and road specification. Contractor will maintained the Road for five years.


## Impacts

Rural road development enhances access to markets for both inputs and outputs through a reduction in transaction and trade cost (transport and logistic cost) The greater availability of inputs increases their use by farmers. consequently, agricultural productivity can increase.

Without physical access rural communities face much greater obstacles in obtaining health, education and other social services in addition their ability to take advantage of employment opportunities is severely constrained. Roads are a key element in the provision of physical access.

This roads directly connected the habitation of Chirki Bazar, Chirkidih, Chalkari mission, Hatyatand with total population approx 4000 and indirectly connected with existing REO road. This roads also connect to State Highway and District Headquarters which is educational, Health and Agricultural market hub of the area An overall growth in rural sector will be visible in for two to three years,

Villagers can sell their agriculture products to near by market people will avail facilities of medical centre easily.
