**Subject: Release of 3<sup>rd</sup> installment of Programme Fund to State Government of Arunachal Pradesh under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the year 2022-23.**

Sir,

I am directed to convey the sanction of the President to the payment of Grants-in-aid as Programme Fund amounting to **Rs. 250,00,00,000/- (Rupees Two Hundred and Fifty Crores only)** to the State Government of Arunachal Pradesh as 3<sup>rd</sup> Installment as Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2022-23.

2. The Programme Fund of **Rs. 250 crore** is being adjusted as per the details given below:-

3. The State Government shall transfer these funds along with the corresponding State Share to **Arunachal Rural Roads Development Agency (ARRDA) within a maximum period of 30 days from the date of receipt of these funds.** The State Government is required to endorse a copy of the release order to the Government of India at the following address:

4. Arunachal Rural Roads Development Agency (ARRDA) has nominated **Shri D. Nyodu, Chief Engineer, Rural Works Department, as the Empowered Officer.**

5. The funds released by the State Government shall be kept in a separate Savings **Bank Account No. 10940060635 (IFSC Branch Code No. SBIN0006091), State Bank of India, Itanagar Branch, Arunachal Pradesh.** It shall be ensured by the Arunachal Rural Roads Development Agency (ARRDA) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana.

6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.

7. No Utilization Certificate is pending from **Arunachal Rural Roads Development Agency (ARRDA).**

8. The State Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on pro-rata basis in term of Rule 230(8) of GFR, 2017. Interest earned should be clearly and separately depicted in PFMS, scheme- specific portals integrated with PFMS and in MIS provided by the banks.

9. The State Government shall ensure the integration of the state treasury with PFMS and all the entries should be reflected on PFMS.

10. The State Nodal Agency shall ensure that sufficient budget provisions are made in the state budget before the request of further funds release.

11. The Utilization Certificate should be submitted within 12 (Twelve) months of the closure of Financial Year which shall include interest accrued. Interest accrued should be computed based on the details of the Ledger Account maintained for the purpose.

12. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the O/o the CCA, Ministry of Rural Development in terms of **Rule 236 (1)** of the General Financial Rules.

13. The expenditure is debitable to the following Head of Accounts under **Demand No.87** Department of Rural Development (2022-23).
