- 3. The State Government shall transfer these funds along with the corresponding State Share to Telangana State Rural Roads Development Agency (TSRRDA) within a maximum period of 30 days from the date of receipt of these funds. In case of delay beyond 30 days in transfer of Central share to SNA account, interest will be charged at 7% per annum.
- 4. Telangana State Rural Roads Development Agency (TSRRDA) has nominated Shri VeeravalliKanakaratnam, Chief Engineer & Empowered Officer of TSRRDA, Hyderabad. The State Government is required to endorse a copy of the release order to the Government of India at the following address:-

5. The funds transferred by the State Government to TSRRDAshall be kept in a separate Savings Bank Account No.110510100114249, (IFSC Code: UBIN0811050), Union Bank of India, Banjara Hills Branch, Road No.1, Reliance Classic Building, Banjara Hills, Hyderabad - 500 034.Implementing Agencies (IAs) down the ladder should use the SNA's Account with clearly defined drawing limits set for that account. It shall be ensured by the State Govt. that the Programme Implementation Units (PIUs) in the districts have ready access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram SadakYojana as per the limits assigned. The Empowered Officer of Telangana State Rural Roads Development Agency (TSRRDA) shall

communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the bank regarding the names of authorized payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from Telangana StateRural Roads Development Authority (TSRRDA).
- 8. The State Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on pro-rata basis in term of Rule 230(8) of GFR, 2017. Interest earned should be clearly and separately depicted in PFMS, scheme-specific portals integrated with PFMS and in MIS provided by the banks.
- 9. The State Government shall ensure the integration of the state treasury with PFMS and all the entries should be reflected on PFMS.
- 10. The State Nodal Agency shall ensure that sufficient budget provisions are made in the state budget before the request of further funds release.
- The Accounts of the grantee institution will be audited by the Comptroller and Auditor General of India and the internal Audit of the O/o the CCA of the Ministry of Rural Development in terms of Rule 236 (1) of the General Financial Rules.
