I am directed to convey the sanction of the President of India for release of an amount of Rs.12,21,87,500/- (Rupees Twelve crore Twenty One Lakh Eighty Seven Thousand and Five Hundred only) to the Union Territory of Puducherry as the Central assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) for the Financial Year 2022-23.

3. The UT administration shall transfer these funds along with matching UT Share to DRDA Pondicherry within a maximum period of 30 days respectively from the date of receipt of these funds. In case of non-transfer beyond this period, Central Government may be constrained to stop further releases. The UT administration is required to endorse a copy of the release order to the Government of India at the following address:

- 4. DRDA Pondicherry has nominated Ms. Rishita Gupta, State Project Director, DRDA, UT of Puducherry as the Empowered Officer.
- 5. The funds released by the UT administration shall be kept in a separate Savings Bank Account No. 6834781323 (IFSC Branch Code No. IDIB000P134), Indian Bank, 42, Vallalar Salai, Kamaraj Nagar, Puducherry, 605011. It shall be ensured by DRDA Pondicherry (DRDAP) that the Programme Implementing Units (PIUs) in the districts have access to the funds and the funds held in the specified account are allowed to be utilized only by the Executing Agency/Agencies for the purpose of approved works under the Pradhan Mantri Gram Sadak Yojana. The Empowered Officer of DRDA Pondicherry (DRDAP) shall communicate to the bank the names of the Authorized Signatories, who will be issuing cheques on the Agency's said bank account for the purpose of this sanction.

- 6. The Empowered Officer shall issue standing instructions to the Bank regarding the names of Authorized Payees and their designated account details and the amounts admissible to each payee. He will also specify limits on monthly payments as per the agreed work programme for the respective package.
- 7. No Utilization Certificate is pending from DRDA Pondicherry (DRDAP).
- 8. The UT Nodal Agency shall ensure that the interest earned from the funds released should be mandatorily remitted to the respective Consolidated Funds on pro-rata basis in term of **Rule 230(8)** of GFR, 2017. Interest earned should be clearly and separately depicted in PFMS, scheme-specific portals integrated with PFMS and in MIS provided by the banks.
- 9. The State Government shall ensure the integration of the state treasury with PFMS and all the entries should be reflected on PFMS.
- 10. The State Nodal Agency shall ensure that sufficient budget provisions are made in the state budget before the request of further funds release.
- 11. The accounts of the grantee institutions will be audited by the Comptroller and Auditor General of India and the Internal Audit of the Principal Accounts Office of the Ministry in terms of **Rule 236 (1)** of the General Financial Rules.
- 12. The expenditure is debitable to the following Head of Account under Demand No. 87 of the Department of Rural Development during the current financial year 2022-23:-
